1. No User Accounts or Personal Data Collection

We do **not** collect:

- Personal identifiers (e.g., name, email, phone number)
- Passwords or login credentials
- Payment or billing information

2. PDF File Uploads and Manual Review

When you upload a PDF to MenuNY:

- The file is submitted voluntarily by you for the purpose of publishing a menu online.
- Each PDF is **manually reviewed** by our team to ensure it complies with our content standards.
- Inappropriate, offensive, misleading, or harmful content will be rejected without notice.
- Once approved, your menu may be published at a unique public URL.

 If approved or rejected, you may receive a confirmation or notification, only if contact information was provided voluntarily (e.g., in the PDF or via separate communication).

We do **not** publish any menus automatically.

3. Content Guidelines

You are responsible for the content you upload. We reserve the right to reject or remove any material that:

- Contains hate speech, harassment, or illegal content
- Violates copyright or intellectual property rights
- Includes personal or sensitive information (e.g., social security numbers, bank details)
- Promotes violence, discrimination, or false claims

4. Cookies and Anonymous Analytics

MenuNY uses minimal cookies and third-party services for:

- Session management (e.g., remembering your last action)
- Anonymous traffic analytics (e.g., page visits, device type)

These cookies do **not** collect personal data or track you across other websites.

You can disable cookies in your browser settings, although some features may not function correctly.

5. Data Security

Although MenuNY collects minimal data, we use standard security practices to:

- Protect files during and after upload
- Prevent unauthorized access or misuse of published menus
- Maintain the integrity and safety of our platform

PDFs and public menus are stored on secure servers.

6. Public Visibility of Approved Content

Menus that are approved are made publicly accessible via a unique URL. These menus may be indexed by search engines like Google.

7. Third-Party Services

We may use trusted third-party services to host our platform or analyze anonymous usage data. These services do not receive any personal information from us.
