- MenuNY has the right to **review, approve, reject, remove, or moderate** any submission without prior notice.
- Approved menus may be published at a public URL and may be **indexed by search engines**.

We reserve the right to reject any content that includes:

- Hate speech, discrimination, or harassment
- Nudity, violence, or offensive material

- False or misleading claims
 - Copyrighted material without authorization
 - Personal data or sensitive information (e.g. SSNs, banking info)
